Presentation to the WTO on Professional Services and Mutual Recognition in APEC, October 2025

With the Australian APEC Study Centre and on behalf of the Australian Government, Paul is co-presenting an update on *Professional Services and Mutual Recognition in APEC* for the WTO's CTS Thematic Session on Recognition of Professional Qualifications.

Designer and Lead Facilitator, APEC Mutual Recognition of Professional Services Community of Practice, Australian APEC Study Centre, 2022-2205
